### **Terms and Conditions**

#### **1. General Requirements**

- Dress codes must follow the style descriptions as specified (Day wear / Night wear)  
Each contestant will be required to express two minutes of “unique your time” showing us your hidden talents e.g.: Creative works – reading poems, props or as simple as a statement meaning something to you
- All bio’s must be attached at the time of the application
- All evening wear must be genuine reproductions and/or original Vintage inspired
- Images used on the Cooly Rocks On™ website and media editions or editorials related to the Miss Rockabilly 2019 event remain the sole right and property of Event Organisers being Connecting Southern Gold Coast Ltd. Organisers reserve the right to use all photos taken by the Events photographer in advertising and social media
- A ‘Photo Release Form’ must be signed by all entrants on arrival at the Event pre-judging
- The finalists of Miss Cooly Rocks On™ will be required to participate in the Festival Street Parade on Sunday 9 June 2019 wearing their sash that will be presented at the Sashing ceremony at a time and place to be specified
- Finalists will be chosen at the discretion of the Selection Panel and all decisions are final. No further discussion will be entered into

- All music that finalists would like to use on stage must be sent to organisers no later than Thursday, 30 May 2019. Details of the format required and where to send music to will be communicated to the finalists in April 2019
